GUIDANCE NOTE 02/2018 (Rev 02)

RECOGNITION OF SHIP'S COOKS ON CAYMAN ISLANDS VESSELS

To: OWNERS, MANAGERS AND MASTERS OF CAYMAN ISLANDS YACHTS AND PASSENGER YACHTS

.

1. BACKGROUND

- 1.1 The Merchant Shipping (Maritime Labour Convention) (Food and Catering) Regulations, 2014 (the Regulations) implements into Cayman Islands law the provisions of Regulation 3.2 of The Maritime Labour Convention, 2006 (MLC, 2006) relating to Food and Catering.
- 1.2 Part 2 of Shipping Notice CISN 07/2014 (as amended) provides guidance on how to comply with the requirements of regulation 8 of the Regulations including the requirement to carry a qualified ship's cook and training, experience and certification requirements. This Guidance Note supplements that Shipping Notice and introduces an optional recognition statement, which may be issued on request by the Cayman Islands Shipping Registry (CISR), recognizing that seafarers working on a Cayman Islands registered Large Yacht or Passenger Yacht demonstrate qualifications and experience that is considered equivalent to that required to obtain a Ship's Cook Certificate.
- 1.3 The Cayman Islands Shipping Registry is issuing these optional recognitions at the request of a number of seafarers who have expressed a desire to be able to show their qualification as a ship's cook through a single document. Such recognitions are issued on a voluntary basis and <u>are not</u> required by either the Merchant Shipping (Maritime Labour Convention) (Food and Catering) Regulations, 2014 or MLC 2006 itself.
- 1.4 For the purposes of MLC 2006, a "ship's cook" is the individual, or individuals, who are responsible for the food and catering services provided to the crew. A visiting chef who is on board who only prepares food for guests and other "non crew members" is not considered as a ship's cook for the purposes of MLC 2006.

2. QUALIFICATION REQUIREMENTS FOR A SHIP'S COOK

2.1 Regulation 8(1) of the Regulations provide that it is the shipowner's responsibility to make sure that a ship to which the MLC, 2006 applies which ordinarily operates with 10

or more seafarers, on voyages of more than 3 days or more than 36 hours from a safe port, carries a fully qualified cook.

- 2.2 A ship's cook must be aged 18 or above and should have evidence of qualifications as a cook, such as:-
 - a) a National Vocational Qualification (NVQ) Level II in catering and hospitality; or certificates of qualification as a ship's cook issued by countries that have ratified the Maritime Labour Convention 2006; or
 - b) certificates of qualification as a ship's cook issued by countries that have ratified the Certification of Ships Cooks Convention, 1946 (No.69); or
 - c) confirmation, supported by a Curriculum Vitae (CV), that they have been serving as a chef in a professional kitchen, commercial yacht or passenger ship and evidence that they have completed training (at managerial level²) in food and personal hygiene, food storage, stock control, and environmental protection and catering health and safety; or
 - d) confirmation, supported by a Curriculum Vitae (CV), that they have served as a ship's cook before the Maritime Labour Convention 2006 has been extended to the Cayman Islands and evidence that they have completed training (at managerial level) in food and personal hygiene, food storage, stock control, and environmental protection and catering health and safety;
- 2.3 Where a professionally qualified chef/cook wishes to demonstrate qualifications and experience as per paragraphs 2.2.4 and 2.2.5 above the CISR may accept such shore-based training for cooks that it considers to be equivalent to the training required under the Standard A3.2 of MLC, 2006 for employment on Cayman Islands ships.
- 2.4 As noted above recognized cook's professional qualifications, such as a City & Guilds qualification, a National Vocational Qualification (NVQ) or a Diploma or a similar qualification obtained from a shore-based catering training establishment are acceptable to the Cayman Islands¹ provided the course contents meet Standard A3.2 of MLC, 2006, and the syllabus includes advanced/managerial level² training on food hygiene and preparation. The chef/cook should hold a valid certificate issued by that shore-based establishment attesting to the completion of specified training. If the course content does not include advanced/managerial level training² on food hygiene and preparation, then separate certificates covering this should be held.
- 2.5 Although there is no legal requirement for the Food Hygiene and Safety certificate to be refreshed, the catering industry best practice is to take a refresher course every 3 to 5 years. As such we would expect a course to have been taken within at least the last 3 years when processing an application. We have no objection to on-line accredited courses.
- 2.6 Seafarers who have obtained the professional qualifications and experience as a cook indicated in section 2.4 and who meet the minimum age requirements will be entitled to

serve as a Ship's Cook on a Cayman Islands vessel as required by regulation 8(1) of the Regulations. However, in response to inquiries from clients the CISR has decided to introduce a purely voluntary 'Recognition of Qualification as a Ship's Cook' statement, recognizing that seafarer's serving on, or intending to serve on Large Yachts and Passenger Yachts to which MLC applies, demonstrate qualifications and experience that is considered appropriate to act as a Ship's Cook on a Cayman Islands vessel.

2.7 The remainder of this Guidance Note addresses the procedure for applying for this voluntary 'Recognition of qualification as a Ship's Cook'.

3. PROCEDURE FOR APPLICATION FOR A 'RECOGNITION OF QUALIFICATION AS A SHIP'S COOK'

- 3.1 Seafarers who meet the requirements in section 2 can apply for a 'Recognition of Qualification as a Ship's Cook' via the CISR website (http://www.cishipping.com/forms). Application forms can be downloaded from this page.
- 3.2 In support of their application applicants should provide copies of:
 - a) all professional qualifications as a cook including evidence of advanced training in food hygiene;
 - b) a CV, when required;
 - c) a valid seafarer Medical Certificate satisfying MLC, 2006 Standard A1.2 or Regulation I/9 of the STCW Convention; and
 - evidence of Basic Training in accordance with Section A-VI/1.2 of the STCW Code.
- 3.3 The voluntary 'Recognition of Qualification as a Ship's Cook' will be valid for a period of 5 years from the date of issue. An example is contained in Annex 1 of this Guidance Note.
